

To match this aspiration with action, we must rediscover our unity and inner strength.



Climate policies on all policy levels








New EU climate targets, new EU Climate Law

- March 2020: EU long term strategy submitted to the UNFCCC committing to climate neutrality by 2050
- Climate neutrality by 2050 is in line with the Paris Agreement goals
- Commission also proposed in March a Climate Law, to enshrine climate neutrality target and adaptation legally
- September 2020: Commission puts forward a plan to further cut emissions by at least **55% by 2030**



Climate neutrality + decarbonising the economy = significant health co-benefits

Climate change is here!



- taking advantage of opportunities that may arise






New EU Adaptation Strategy: the ambition

- Improve knowledge of climate impacts
- **Reinforce planning** and climate risk management
- Accelerate action with a focus on
 - *solutions* (in addition to understanding)
 - *innovation* (in addition to research)
 - *implementation* (in addition to planning)
 - prevention (in addition to ex-post)





New EU Adaptation Strategy: some key areas

- Finance & 'climate protection gap'
- Data, knowledge, know-how
- Climate proofing of infrastructure, 'build back better'
- Adapting forests, agriculture, ecosystems
- Working in and with cities and local communities
- Reinforced global action
- Last but not least: health!





New EU Adaptation Strategy: timeline

- 2019 Green Deal Communication
 - Announcement of the strategy
- 2020 proposal for EU Climate Law
 - Article 4: adaptation a legal requirement
- 2021: new EU Adaptation Strategy
 - expected in late February 2021



European Climate and Health Observatory: Objectives

- Improve the knowledge base for policy making and practice
- Connect and pool knowledge, expertise, tools, organisations
- Facilitate learning across countries
- Support the EU Green Deal, EU4Health and the new EU Adaptation Strategy





European Climate and Health Observatory: Implementation

- Partnership led by European Commission and EEA
- Several other partner organisations involved and providing content
- Hosted on the Climate-ADAPT platform
- Covers 32 EEA member countries and 6 cooperating countries
- Launch of <u>pilot version</u> in February/March 2021
